

Appendix F – Site Audit Findings and Corrective Actions

- 1.1.1 Site Inspections were carried out on a weekly basis to monitor the implementation of proper environmental pollution control and mitigation measures for the Project. During the reporting period, thirteen site inspections were carried out on 7, 14, 20, and 28 October 2015, 4, 11, 18, and 25 November 2015, and 2, 9, 16, 23 and 30 December 2015.
