Please be reminded to keep close attention on keeping the site haul road leading to East Coast Road and associated access road clear of dusty materials as required under Air Pollution Control (Construction Dust) Regulation, Schedule Part III, clause 14 – Access Road, and to urge ET to increase the inspection frequency (e.g., daily) to continuously check the effectiveness of the mitigation measures and recommend further appropriate measures for prompt rectification on any observed deficiency.

#### **EXECUTIVE SUMMARY**

This Monthly Environmental Monitoring and Audit (EM&A) Report is prepared for Contract HY/2013/02 "Hong Kong–Zhuhai-Macao Bridge Hong Kong Boundary Crossing Facilities (HKBCF) – Infrastructure Works Stage I (Western Portion)" (hereafter referred to as "the Contract") for the Highways Department of Hong Kong Special Administrative Region (HKSAR). The Contract was awarded to China Harbour Engineering Co., Ltd. (hereafter referred to as "the Contractor") and ETS-Testconsult Limited was appointed as the Environmental Team (ET) by the Contractor.

The Contract is part of Hong Kong–Zhuhai–Macao Bridge HKBCF which is a "Designated Project", under Schedule 2 of the Environmental Impact Assessment Ordinance (EIAO) (Cap 499) and Environmental Impact Assessment (EIA) Report (Register No. AEIAR-145/2009) was prepared for the Project. The current Environmental Permit (EP) No. EP-353/2009/K for HKBCF was issued on 11 April 2016. These documents are available through the EIA Ordinance Register. Site preparation works of the Contract was started on 25 July 2014 and the construction works of the Contract commenced on 24 November 2014.

ETS-Testconsult Limited has been appointed by the Contractor to implement the Environmental Monitoring & Audit (EM&A) programme for the Contract in accordance with the Updated EM&A Manual for HKBCF (Version 1.0) and provide environmental team services to the Contract.

This is the fortieth Monthly Environmental Monitoring and Audit (EM&A) Report for the Contract which summaries findings of the EM&A works conducted during the reporting period from 01 March to 31 March 2018.

#### Site Activities

As informed by the Contractor, site activities were carried out in this reporting month:

- Landscaping work
- Road Furniture & Fit out

#### Environmental Monitoring and Audit Progress

The monthly EM&A programme was undertaken in accordance with the Updated EM&A Manual for HKBCF (Version 1.0). It should be noted that the air quality and noise monitoring works for the Contract are covered by Contract No. HY/2013/01 "Hong Kong-Zhuhai-Macao Bridge HKBCF – Passenger Clearance Building" and Contract No. HY/2011/03 "Hong Kong-Zhuhai-Macao Bridge Hong Kong Link Road – Section between Scenic Hill and HKBCF". The ET of the Contract or another ET of the HZMB project is required to conduct impact air quality monitoring at AMS6 and AMS7B, noise monitoring at NMS2 and NMS3B, water quality monitoring show in **Figure 2** and dolphin monitoring show in **Figure 3** as part of EM&A programme if these monitoring stations are no longer covered under Contract No. HY/2013/01 and HY/2011/03. However, this is subject to ENPO's final decision on which ET should carry out the monitoring works at these stations. The dates of site inspection during the reporting period are listed below:

Environmental Site Inspection: 01, 08, 15, 22 & 29 March 2018

#### Breaches of Action and Limit Levels

Summary of Action and Limit Level exceedance of 1-hr TSP level and 24-hr TSP level at AMS6 shall be referred to the monthly EM&A report prepared by Contract No. HY/2011/03.

There was no Action and Limit Level exceedance of 1-hr TSP level and 24-hr TSP level recorded at station AMS7B by the Environmental Team of Contract No. HY/2013/01 during the reporting period.

There was no Action and Limit Level exceedance for noise recorded at station NMS2 and station NMS3B by the Environmental Team of Contract No. HY/2013/01 during the reporting period.

During March 2018, there were four action level exceedances of suspended solids recorded on 02, 16, 21 and 30 March 2018. Since the removal of temporary loading and unloading point by Contract No. HY/2013/02, which involved marine work, was completed on 10 September 2017 and the area was handed back to Reclamation Contractor with Contract No. HY/2010/02 on 11 September 2017 for subsequent seawall construction as confirmed by RSS, there was no marine works or barge of this Contract worked at

HKBCF reclamation site near the sea area or area near the monitoring station under Contract No. HY/2013/02 during March 2018. Hence, specific investigation shall be referred to other ET's report(s) under the HZMB Projects in which the respective contract(s) with remaining marine works on-going for the exceedances recorded in water quality monitoring during this reporting month. There was no Action and Limit Level exceedance recorded on other monitoring date at the monitoring stations showed at **Table 4.1** by the Environmental Team of Contract No. HY/2013/01 during the reporting period.

#### Complaint Log

Follow-up action to the complaint received by *Environmental Protection Department* on 05 February 2018 and referred to the ENPO on 05 February 2018. Then the ENPO forwarded the complaint by email to the R.E. (AECOM), the Contractor (China Harbour) and the ET (ETS-Testconsult Ltd.) of Contract No. HY/2013/02 at 11:26 on 05 February 2018. After received the details of the complaint from the ENPO on 05 February 2018, a related follow-up inspection was conducted by ET and the Contractor of Contract No. HY/2013/02 to investigate this event. The inspection was concentrated to check if washing facilities provided after 19:00. After checked with the Contractor of Contract No. HY/2013/02, the washing facilities were provided after 19:00 and vehicles were cleaned before leaving the construction site. Besides, the washing facilities were also provided before receiving the complaint (see attached photo 180208\_002 & 180208\_003). Hence, the complaint received on 05 February 2018 was found non-related to Contract No. HY/2013/02.

A follow up complaint with details as follows: "就上次投訴指出港珠澳大橋人工島於晚上七時後無人洗車及截 水,經環保署跟進後雖然有所改善,但約維持一個月左右,現時洗車池仍然經常無人清洗輪軚、以及截水情況 依然無改善就本人曾經發現水喉,嘗試自行清洗輪軚時,被中國港灣人員阻止,稱有 CCTV 錄影,不可自行 清洗" received by *Environmental Protection Department* and referred to the ENPO on 09 March 2018. Then the ENPO forwarded the complaint by email to the R.E. (AECOM), the Contractor (China Harbour) and the ET (ETS-Testconsult Ltd.) of Contract No. HY/2013/02 at 17:38 on 10 March 2018. A related follow-up inspection was conducted on 12 March 2018 to investigate this event. The washing facilities were provided after 19:00 during inspection. Besides, the washing facilities were also provided before receiving the follow up complaint. After checking with the contractor of Contract No. HY/2013/02, there were no night works after 19:00 by Contract No. HY/2013/02 on 08 March 2018. The wheel washing facilities would only be provided if there were works conducted within the site area of Contract No. HY/2013/02. Hence, the follow up complaint received on 09 March 2018 was found non-related to Contract No. HY/2013/02.

The complaint investigation report (Log No. 018) was provided in Appendix J.

#### Notifications of Summons and Successful Prosecutions

There were no notifications of summons or prosecutions received during the reporting period.

# 1. INTRODUCTION

#### 1.1. Basic Project Information

- 1.1.1. This Monthly Environmental Monitoring and Audit (EM&A) Report is prepared for Contract HY/2013/02 "Hong Kong–Zhuhai-Macao Bridge Hong Kong Boundary Crossing Facilities (HKBCF) – Infrastructure Works Stage I (Western Portion)" (hereafter referred to as "the Contract") for the Highways Department of Hong Kong Special Administrative Region (HKSAR). The Contract was awarded to China Harbour Engineering Co., Ltd. (hereafter referred to as "the Contractor") and ETS-Testconsult Limited was appointed as the Environmental Team (ET) by the Contractor.
- 1.1.2. The Contract is part of Hong Kong–Zhuhai–Macao Bridge HKBCF which is a "Designated Project", under Schedule 2 of the Environmental Impact Assessment Ordinance (EIAO) (Cap 499) and Environmental Impact Assessment (EIA) Report (Register No. AEIAR-145/2009) was prepared for the Project. The current Environmental Permit (EP) No. EP-353/2009/K for HKBCF was issued on 11 April 2016. These documents are available through the EIA Ordinance Register. Site preparation works of the Contract started on 25 July 2014 and the construction works of the Contract commenced on 24 November 2014. The works area of the Contract is shown in Appendix A.
- **1.1.3.** The proposed works under this Contract comprise the following:
  - Construction of the viaducts and roads at the western portion of Hong Kong Boundary Crossing Facilities (HKBCF) mainly for connection with the Hong Kong–Zhuhai–Macao Bridge (HZMB), Hong Kong Link Road (HKLR), Hong Kong International Airport (HKIA) and the Tuen Mun-Chek Lap Kok Link (TM-CLKL);
  - Construction of the road modification at the SkyCity Interchange at Airport Island;
  - Construction of associated street lighting, street furniture, road marking, road signage, drainage, sewerage, fresh water and flushing water supply, irrigation, landscape, electrical and mechanical (E&M), utilities and services works;
  - Provisioning of civil engineering works and power supply installation for the Traffic Control and Surveillance System TCSS;
  - Other works in accordance with the Contract.
- **1.1.4.** This is the fortieth Monthly Environmental Monitoring and Audit (EM&A) Report for the Contract which summaries the audit findings of the EM&A programme during the reporting period from 01 March to 31 March 2018.

**3.3.1** The monitoring results for NMS2 and NMS3B are reported in the monthly EM&A Reports prepared for Contract No. HY/2013/01. There was no exceedance for noise recorded at station NMS2 and station NMS3B by the Environmental Team of Contract No. HY/2013/01 during the reporting period.

# 4. WATER QUALITY MONITORING

#### 4.1. Monitoring Locations

The water monitoring works for the Contract are covered by Contract No. HY/2013/01 Hong Kong-Zhuhai-Macao Bridge HKBCF – Passenger Clearance Building. The ET of the Contract or another ET of the HZMB project is required to conduct water quality monitoring at twenty one stations (9 Impact Stations, 7 Sensitive Receiver Stations and 5 Control/Far Field Stations). Due to topographical conditions of SR3, SR10A and SR10B(N), the water quality monitoring (WQM) stations was proposed to be monitored at alternative WQM stations named as SR3(N), SR10A (N) and SR10B(N2). The proposal for alternation of water quality monitoring stations for HZMB HKBCF was justified by the ET Leader for Contract No. HY/2013/01 on 08 November 2017 and verified by the IEC on 13 November 2017; and submitted to EPD on 29 November 2017, and it was approved by EPD on 22 December 2017. **Table 4.1** and **Figure 2** shows the locations of water quality monitoring stations.

#### 4.3 Monitoring Result

- **4.3.1** The monitoring results for the monitoring stations showed in **Table 4.1** are reported in the monthly EM&A Report prepared for Contract No. HY/2013/01. During March 2018, there were four action level exceedances of suspended solids recorded on 02, 16, 21 and 30 March 2018.
- **4.3.2** Since the removal of temporary loading and unloading point by Contract No. HY/2013/02, which involved marine work, was completed on 10 September 2017 and the area was handed back to Reclamation Contractor with Contract No. HY/2010/02 on 11 September 2017 for subsequent seawall construction as confirmed by RSS, there was no marine works or barge of this Contract worked at HKBCF reclamation site near the sea area or area near the monitoring station under Contract No. HY/2013/02 during March 2018. Hence, specific investigation shall be referred to other ET's report(s) under the HZMB Projects in which the respective contract(s) with remaining marine works on-going for the exceedances recorded in water quality monitoring during this reporting month. There was no Action and Limit Level exceedance recorded on other monitoring date at the monitoring stations showed at **Table 4.1** by the Environmental Team of Contract No. HY/2013/01 during the reporting period.
- **4.3.3** Although the exceedances were not relevant to this Contract, the Contractor was reminded to provide appropriate water pollution mitigation measures, such as ensure all construction activities that would deteriorate the water quality was collected by sedimentation tanks or package treatment systems for proper treatment prior to disposal.

#### 5. DOLPHIN MONITORING

#### 5.1. Monitoring Locations

The dolphin monitoring works for the Contract are covered by Contract No. HY/2013/01 Hong Kong-Zhuhai-Macao Bridge HKBCF – Passenger Clearance Building. The ET of the Contract or another ET of the HZMB project is required to conduct dolphin monitoring at 24 transects as part of EM&A programme if these transects are no longer covered under Contract No. HY/2013/01. The dolphin monitoring should adopt line-transect vessel survey method. The survey follows pre-set and fixed transect lines in the two areas defined by AFCD as: Northeast Lantau survey area; and Northwest Lantau survey area. **Figure 3** shows the co-ordinates for the transect lines and layout map.

### 6. ENVIRONMENTAL SITE INSPECTION AND AUDIT

#### 6.1. Site Inspection

- **6.1.1.** Site Inspections were carried out on a weekly basis to monitor the implementation of proper environmental pollution control mitigation measures for the project. During the reporting period, site inspections were carried out on 01, 08, 15, 22 & 29 March 2018.
- **6.1.2.** As confirmed by RSS on 16 January 2018, the landscape construction works including planting (Shrubs & Grass), installation of irrigation pipe and soiling (Sub & Top soil) for Contract No. HY/2013/02 were commended on 04 November 2017. The landscape inspections were conducted on 08 and 22 March 2018 on a bi-weekly basis during the weekly environmental site inspection. The weekly site inspection checklists including the landscape inspection items would be submitted to IEC for checking within the reporting period.
- **6.1.3.** During the site inspections on March 2018, there was no conflict occurred regarding to the Landscape & Visual mitigation measures stated in Contract Specific EM&A Manual. The work site was found to be confined within site boundaries and grass-hydroseed was provided for bare soil surface and stock pile areas. Landscape & Visual mitigate measures during construction would be checked to ensure compliance with the intended aims of the measures.
- **6.1.4.** Particular observations during the site inspections are described below:

#### 22 February 2018

(a) Extra intersection was found after the wheel washing facility at Portion A. The intersection was closed immediately at Portion A. The observation was closed on 01 March 2018.

#### 01 March 2018

(a) Uncovered cement pack was observed at Portion F. Cement pack was cleaned at Portion F. The observation was closed on 08 March 2018.

#### 08 March 2018

(a) Vehicle U-turning at C2 & C4 intersection without wheel washing was observed. Road signing was displayed at C2 & C4 intersection. The observation was closed on 15 March 2018.

#### 15 March 2018

(a) Emission of dense smoke from a tiller was observed at Portion F. No emission of white smoke from the tiller after maintenance. The observation was closed on 22 March 2018.

Reminder 1 – The contractor was reminded to provide watering whenever fugitive dust was observed.

#### 22 March 2018

(a) Dusty material was observed on the haul road at Portion C. Dusty material was cleaned on the haul road at Portion C. The observation was closed on 29 March 2018.

#### 29 March 2018

(a) Substandard NRMM on an excavator was observed at Portion D. Follow-actions for outstanding observation will be inspected during the next site inspection.

#### 6.2. Advice on the Solid and Liquid Waste Management Status

- **6.2.1.** The Contractor registered as a chemical waste producer for the Contract. Sufficient numbers of receptacles were available for general refuse collection and sorting.
- **6.2.2.** There was no excavated marine sediment generated in this reporting period. Since the disposal of excavated marine sediments has been completed with the last batch disposal on 30 August 2017 as confirmed by RSS, no excavated marine sediment was still remained and stored on site awaiting disposal during this reporting period under Contract No. HY/2013/02.



#### 6.3. Environmental Licenses and Permits

6.3.1. The valid environmental licenses and permits during the reporting period are summarized in Appendix F.

#### 6.4. Implementation Status of Environmental Mitigation Measures

- **6.4.1.** In response to the site audit findings, the Contractor carried out corrective actions.
- **6.4.2.** The Contractor waters 8 times per day on all exposed soil within the project site and associated works areas when construction activities are being undertaken.
- **6.4.3.** The Contractor was reminded to resolve the potential conflicts between the proposed landscape measures and any other works of the project. The landscape works with mitigation code G1, G2, G4, G6, G7 & G9 were conducted around the site under construction stage while landscape works with mitigation code G5 was mainly conducted at Portion D. The implementation status of Landscape and Visual Mitigation Measures is presented in **Appendix G**.
- **6.4.4.** The Contractor was reminded to provide well-maintained plant operated on-site and plant served regularly;
- 6.4.5. The Contractor was reminded to switch off vehicles and equipment while not in use;
- 6.4.6. The Contractor was reminded to schedule the construction works to minimize noise nuisance etc.
- **6.4.7.** A summary of the implementation Schedule of Environmental Mitigation Measures (EMIS) is presented in **Appendix G**. Most of the necessary mitigation measures were implemented properly.

#### 6.5. Summary of Exceedance of the Environmental Quality Performance Limit

- **6.5.1.** Summary of Action and Limit Level exceedance of 1-hr TSP level and 24-hr TSP level at AMS6 shall be referred to the monthly EM&A report prepared by Contract No. HY/2011/03.
- **6.5.2.** There was no Action and Limit Level exceedance of 1-hr TSP level and 24-hr TSP level recorded at station AMS7B by the Environmental Team of Contract No. HY/2013/01 during the reporting period.
- **6.5.3.** There was no Action and Limit Level exceedance for noise recorded at station NMS2 and station NMS3B by the Environmental Team of Contract No. HY/2013/01 during the reporting period.
- **6.5.4.** The monitoring results for the monitoring stations showed in **Table 4.1** are reported in the monthly EM&A Report prepared for Contract No. HY/2013/01. During March 2018, there were four action level exceedances of suspended solids recorded on 02, 16, 21 and 30 March 2018.
- **6.5.5.** Since the removal of temporary loading and unloading point by Contract No. HY/2013/02, which involved marine work, was completed on 10 September 2017 and the area was handed back to Reclamation Contractor with Contract No. HY/2010/02 on 11 September 2017 for subsequent seawall construction as confirmed by RSS, there was no marine works or barge of this Contract worked at HKBCF reclamation site near the sea area or area near the monitoring station under Contract No. HY/2013/02 during March 2018. #### 6.6. Summary of Complaints, Notification of Summons and Successful Prosecution

Then the ENPO forwarded the complaint by email to the R.E. (AECOM), the Contractor (China Harbour) and the ET (ETS-Testconsult Ltd.) of Contract No. HY/2013/02 at 11:26 on 05 February 2018. After received the details of the complaint from the ENPO on 05 February 2018, a related follow-up inspection was conducted by ET and the Contractor of Contract No. HY/2013/02 to investigate this event. The inspection was concentrated to check if washing facilities provided after 19:00. After checked with the Contractor of Contract No. HY/2013/02, the washing facilities were provided after 19:00 and vehicles were cleaned before leaving the construction site. Besides, the washing facilities were also provided before receiving the complaint (see attached photo 180208\_002 & 180208\_003). Hence, the complaint received on 05 February 2018 was found non-related to Contract No. HY/2013/02.

A follow up complaint with details as follows: "就上次投訴指出港珠澳大橋人工島於晚上七時後無人洗 車及截水,經環保署跟進後雖然有所改善,但約維持一個月左右,現時洗車池仍然經常無人清洗輪軚、 以及截水情況依然無改善就本人曾經發現水喉,嘗試自行清洗輪軚時,被中國港灣人員阻止,稱有 CCTV 錄影,不可自行清洗" received by *Environmental Protection Department* and referred to the ENPO on 09 March 2018. Then the ENPO forwarded the complaint by email to the R.E. (AECOM), the Contractor (China Harbour) and the ET (ETS-Testconsult Ltd.) of Contract No. HY/2013/02 at 17:38 on 10 March 2018. A related follow-up inspection was conducted on 12 March 2018 to investigate this event. The washing facilities were provided after 19:00 during inspection. Besides, the washing facilities were also provided before receiving the follow up complaint. After checking with the contractor of Contract No. HY/2013/02, there were no night works after 19:00 by Contract No. HY/2013/02 on 08 March 2018. The wheel washing facilities would only be provided if there were works conducted within the site area of Contract No. HY/2013/02. Hence, the follow up complaint received on 09 March 2018 was found non-related to Contract No. HY/2013/02.

The complaint investigation report (Log No. 018) was provided in Appendix J.

- **6.6.1.** There were no notifications of summons or prosecutions received during the reporting period.
- 6.6.2. Statistics on environmental complaints, notifications of summons and successful prosecutions are summarized in Appendix H.



Figure 1 Air Quality and Noise Monitoring Stations for HKBCF






Figure 2Water Quality Monitoring Stations (construction phases)








Figure 3 Dolphin Monitoring Transect Line and Layout Map



**Location of Works Areas** 







## **Circumstances:**

One complaint was received by Environmental Protection Department on 05 February 2018 and referred to the ENPO on 05 February 2018. Then the ENPO forwarded the complaint by email to the R.E. (AECOM), the Contractor (China Harbour) and the ET (ETS-Testconsult Ltd.) of Contract No. HY/2013/02 at 11:26 on 05 February 2018. The complaint detail was "根據《空氣污染管制(建造工程塵埃)規例》地盤應在指定的車輛出口處安裝輸胎清洗設施但每日晚上 7 點後就會 被地盤管理人員截水,使所有車輛無法洗清輸胎而走出工地,令地面堆積沙塵及泥漿,影響 其他道路使用者及環境衛生。要求當局加強巡查,令工地遵守規例'

A follow up complaint with details as follows: "就上次投訴指出港珠澳大橋人工島於晚上七時 後無人洗車及截水,經環保署跟進後雖然有所改善,但約維持一個月左右,現時洗車池仍然 經常無人清洗輪軚、以及截水情況依然無改善就本人曾經發現水喉,嘗試自行清洗輪軚時, 被中國港灣人員阻止,稱有 CCTV 錄影,不可自行清洗" received by Environmental Protection Department and referred to the ENPO on 09 March 2018. # **Details of Follow up action(s)**

After received the details of the complaint from the ENPO on 05 February 2018, a related followup inspection was conducted by ET and the Contractor of Contract No. HY/2013/02 to investigate this event. The inspection was concentrated to check if washing facilities provided after 19:00. After checked with the Contractor of Contract No. HY/2013/02, the washing facilities were provided after 19:00 and vehicles were cleaned before leaving the construction site (see attached photo 180208\_001). Besides, the washing facilities were also provided before receiving the complaint (see attached photo 180208\_002 & 180208\_003). Hence, the complaint received on 05 February 2018 was found non-related to Contract No. HY/2013/02.

For the follow up complaint received on 09 March 2018, a related follow-up inspection was conducted on 12 March 2018 to investigate this event. The washing facilities were provided after 19:00 during inspection (see attached photo 180312\_001). Besides, the washing facilities were also provided before receiving the follow up complaint (see attached photo 180224\_001 & 180307\_001). After checking with the contractor of Contract No. HY/2013/02, there were no night works after 19:00 by Contract No. HY/2013/02 on 08 March 2018. The wheel washing facilities would only be provided if there were works conducted within the site area of Contract No. HY/2013/02. Hence, the follow up complaint received on 09 March 2018 was found non-related to



Contract No. HY/2013/02.

Although these complaints were non-related to Contract No. HY/2013/02, the Contractor of HY/2013/02 was reminded to prohibit any un-cleaned vehicles from leaving the construction site, provide wheel washing facilities if there were night works of Contract No. HY/2013/02, keep the reminders at the wheel washing basin and exit to remind all Contract(s) vehicles using the site exit for proper wheel washing for the proper implementation of environmental mitigation measures associated with the site exit.

In between these two complaints, there were some adjustments of the wheel washing facilities. Due to the diversion of traffic, the vehicles under Contract No. HY/2013/02 would only pass through the paved haul road and thus wheel washing facilities would only be provided at the intersection with other contract and the site exit (East Coast Road gate) since 01 March 2018. Haul road cleaning was provided at the site exit for 24 hours if any muddy condition was found. All vehicles of other contracts from entering the site area of Contract No. HY/2013/02 should be cleaned and all the haul roads are hard paved and thus self wheel washing facilities were not required. Haul road cleaning would be carried out at site exit to ensure the paved roads leading to site entrance are clean. The RSS's agreed updated wheel washing facilities plan and road washing / cleaning plan was attached below. The Wheel Washing Facilities will be removed when the intersections are closed (tentatively scheduled at the end of April 2018).

In order to assort with the new arrangement of washing facilities, follow-up site inspections were performed. Washing facilities with high pressure water jet at the intersection with other contract and the site exit (East Coast Road gate) was provided. The road section between the washing facilities and the exit point was hard paved and water lorries were arranged regularly to clean the road section between washing facilities and site exit. Notices were adhered at the intersection between muddy area and haul roads in order to remind the vehicles to pass through the washing facilities before leaving the site. The photos taken during the follow-up inspections were attached (photo 180315 001, 002, 003 & 004).

## Details of Action(s) Taken by the Contactor of Contract No. HY/2013/02

- 1. Provide notices at the intersection between muddy area and haul roads in order to remind the vehicles to pass through the washing facilities before leaving the site;
- 2. Provide wheel washing facilities with high pressure water jet at the intersection with other contract and the site exit (East Coast Road gate) in order to prohibit any un-cleaned vehicles from leaving the construction site;
- 3. Arrange water lorries regularly to clean the road section between washing facilities and site exit

### Conclusion

Refer to the above mentioned inspection, washing facilities were provided after 19:00. Mitigation measures under the item A2 and W2 of EMIS were implemented including provide vehicle washing facilities with high pressure water jet at the intersection with other contract and the site exit (East Coast Road gate), all vehicles and plant were cleaned before they leave the construction site, provide notice to remind the vehicles to pass through the washing facilities before leaving the site. Hence, the complaint was found non-related to Contract No. HY/2013/02.




