

Appendix F - Site Audit Findings and Corrective Actions

Site Inspections were carried out on a weekly basis to monitor the implementation of proper environmental pollution control and mitigation measures for the Project. During the reporting period, site inspections were carried out on 7, 14, 21 and 30 December 2016 and 4, 11, 18 and 27 January 2017 and 3, 8, 15, 22 and 28 February 2017.
