

Appendix F - Site Audit Findings and Corrective Actions

Environmental site inspections were carried out on a weekly basis to monitor the implementation of proper environmental pollution control and mitigation measures for the Project. During the reporting period, site inspections were carried out on 3, 10, 17 and 26 June 2020; 2, 8, 15, 22 and 31 July 2020; and 5, 12, 21 and 28 August 2020.
